Following introduction of guests, the president asked for a review of the secretary's report as emailed. Lydia Coakley reviewed sponsorship levels for the Oktoberfest; Sue Henwood moved that we donate \$500, seconded by Denise Wingard and carried.

In announcements, the Perry County Housing Coalition will have their annual fundraiser on Saturday, October 19, at St. Rose Community Center, 5:00 to 10:00 p.m.;there will be both silent and live auctions.

Jennifer Moore of Stebelton-Snider spoke on the need for estate planning tools. The first is a last **will and testament**, but also a **financial power of attorney** and a **health care power of attorney**. **A living will** kicks in if two doctors declare you permanently unconscious. If there is no **POA**, in the case of incompetence, a guardianship may be sought by someone not of your choosing. The **last will and testament** allows you to say where you want your belongings to go and is overseen by an executor you choose. The executor is activated only when appointed by probate. Opportunities to avoid probate on property in your name include **Transfer on Death**, joint ownership with right of **survivorship** or **Trusts**. **Trusts** are best if there are minor children involved; revokable trusts allow you to move things in or out at will, whereas irrevocable trusts do not. Jennifer encouraged people to contact her for information specific to their circumstances.
