BREMEN AREA CHAMBER OF COMMERCE minutes of the October 24, 2024 meeting

The Bremen Area Chamber of Commerce met at noon at the Rushcreek Pub & Grub. Vice president Rich Lines opened the meeting in the absence of David Foltz and introduced Tracy Thompson of the Bureau of Workman's Compensation. This is a program that covers 75% of Ohio workers; premiums paid by the employers are based on their payroll figures times the risk classes their workers face. The BWC will do a confidential inspection of the work place and make recommendations in regard to industrial hygiene and safety. The BWC has no enforcement power. This means its worth is based on management and employees buying into and supporting its recommendations.. Lifting and overexertion claims are the most prevalent; transportation has the most fatalities. Concerns include hearing loss and indoor air quality, especially carbon monoxide levels, as well. BWC offers members safety talks to employees and safety grants to businesses for equipment that will increase productivity and decrease injuries. The latter cannot replace an employee and must be kept at least one year. Participation in **safety council's** presentations with speakers, updates on regulations and equipment, and networking opportunities can earn a business a 3% premium rebate.

Minutes of the September meeting were approved as e-mailed on a motion by Dee Mowry, seconded by David Weber and carried. The treasurer reported the following account balances:
